7.2 BIOMETRISCHES FOTO

To apply for your ETA for New Zealand, the visa office needs a photo of you.

You can either have a current biometric passport photo taken by a photographer and send us the photo by mail or as a clear scan by e-mail. It is also possible to send the photo directly to us digitally from your photographer - please state the full name when sending! Dimensions of the biometric photo according to the standard: 3.5×4.5 centimeters.





Alternatively, you can also take an independent photo with a camera/smartphone. Please make sure that the photo is taken in front of a white and clean background (no wallpaper texture!) and that your face does not have any shadows. The exposure must also look natural and the photo must be sent to us in full resolution. The photo must include the shoulder area and provide space above the head.
